

STUDY VISA

UNIVERSITY ENROLMENT

Academic year 2025 - 2026

Visa Type : D-Type National Visa Duration: from 91 up to 365 days

Number of entries: multiple

Deadline to submit the visa application: 30 November 2025 (except foundation courses)

Time limits to apply for the visa: no more than six months before the intended travel date and no later than

15 days before the intended travel date

Time limit to conclude the procedure: 90 days

Overview

The D-Type National Visa for "Study - University Enrolment" allows entering Italy based on admission to any of the following courses at an Italian university (public or private) accredited by the Italian Ministry of Education and Merit:

- 3-year Bachelor's degree (Laurea);
- 2-year Master's degree (Laurea magistrale);
- 5 or 6-year-single-cycle Master's degree.

That also includes the following institutions: AFAM (Istituti di alta formazione artistica, musicale e coreutica), SSML (Scuole superiori per mediatori linguistici), Postgraduate Institutes of Psychotherapy (Istituti di Specializzazione in Psicoterapia), and ITS (Istituti Tecnici Superiori).

This type pf visa only applies to students enrolled in the first academic year.

Timeline

Applications are processed within the following timeframe:

- No more than 6 months before the planned travel date;
- No less than 15 days before the planned travel date.

The deadline to apply for the Study Visa for university enrolment in the academic year 2025-2026 is **30 November 2025** (except for Foundation Courses).

The procedure can take up to a maximum of 90 calendar days.

Please note that the passport is returned to the applicant only once a final decision is taken.

Who can apply

Only applicants holding a valid Abu Dhabi residence visa can apply at the Embassy of Italy in Abu Dhabi. GCC citizens can apply if they prove that they are Abu Dhabi residents by submitting their Emirates ID, Tawtheeq / title deed and water and electricity bills (theirs, or their sponsors').

Residents of Dubai and Northern Emirates have to refer to the Consulate General of Italy in Dubai.



How to book an appointment

Appointments at the Embassy can be booked through the portal Prenot@ami (prenotami.esteri.it).

The Embassy reserves the right to invite the applicant for an interview or to request additional documents.

Pre-Enrolment

Students shall apply for the pre-enrolment online through the web page universitaly.it.

When the University approves the pre-enrolment, the student will receive an e-mail, advising to contact the Embassy in order to apply for the Study Visa.

Authenticity and Comparability

Before applying for the Visa, the student must attest the authenticity and comparability of their educational qualifications.

For both processes, the student must refer to the country where the accreditation body of the curriculum is headquartered, regardless of where the school is physically located.

The <u>Consular Office at the Embassy of Italy in Abu Dhabi</u> can only recognize the authenticity and comparability of certificates obtained in UAE with the following curricula: Emirati, SABIS and MOE.

To attest the authenticity, educational certificates must be either legalized or apostilled.

- Legalization applies to certificates issued by institutions whose accreditation body is
 headquartered is a country <u>not party</u> to the 1961 "Hague Convention Abolishing the Requirement
 of Legalization for Foreign Public Document". It can be obtained by contacting the Consulate or
 Embassy of Italy competent for the area where the accreditation body of the curriculum is
 headquartered.
- **Apostille** applies to certificates issued by institutions whose accreditation body is headquartered in a country <u>party</u> to the 1961 "Hague Convention Abolishing the Requirement of Legalization for Foreign Public Document". It can be obtained by contacting the competent Government Authorities of the country where the Institution is headquartered.

If the University in Italy accepts CIMEA Statement of Verification as **proof of authenticity**, the Visa Office may also accept it, in lieu of what listed above.

<u>Diploma</u>, transcripts and A-Levels/APs/IB certificates, including the Apostille, must be translated into Italian by a legal translator attested in the UAE. You can find at the link a list of legal translators.

In addition to their authenticity, the student must prove the certificates' **comparability** with the correspondent degree in the Italian educational system.

For this purpose, the student shall submit one of the following:

- **Declaration of Value (DOV):** The student must request it from the Consulate or Embassy of Italy competent for the area where the accreditation body of the curriculum is headquartered.
- **CIMEA Statement of Comparability (SOC):** In case the University in Italy accepts CIMEA Statement of Comparability (SOC) as proof of comparability, the Visa Office may also accept it in lieu of the Declaration of Value. To apply for the CIMEA SOC, kindly access the webpage www.cimea.it.

The Consulate General reserves the right to ask for a Personal Interview or any additional documents.

I also understand that if the visa is granted, within eight working days from the arrival in Italy, students must apply for the Permit of Stay ("Permesso di soggiorno") to the relevant Police Headquarter ("Questura"). The form must be filed through authorized Post Offices (Sportello Amico), using the relevant kit available there. Following to that, the student will receive an invitation letter with details of the appointment scheduled by the Police Headquarters. The day of the appointment 2 pictures will be required.
